# Committee Functions and Terms of Reference

# **Functions of the Committee**

The Committee is established under *Standing Order* 69; an Order made pursuant to the *Constitution*<sup>1</sup> and has the functions, together with the necessary powers to discharge such, to:

- (a) examine the accounts prescribed by Section 33 of the Public Finance and Audit Act 1978, together with the report of the Auditor General thereon, and to report the results of such examination to Parliament;
- (b) establish the causes of any excesses over authorised expenditure and to make recommendations to Parliament on any appropriate measures to cater for such excesses of expenditure;
- (c) examine such other accounts laid before Parliament as the Committee may think fit, together with any auditor's report thereon and to report the results of such examination to Parliament;
- (d) summon any public officer to give information on any explanation, or to produce any records or documents which the Committee may require in the performance of its duties;
- (e) consider in detail the Draft Estimates prepared by the Government in support of the Annual Appropriation Bill;
- (f) summon and examine the Accounting Officers and Technical staff of Ministries and Departments and require the production of background information and explanation in relation to Draft Estimates;
- (g) report to Parliament in such a way that the report may inform Members prior to the Parliamentary debate thereon of the background to the Draft Estimates draw attention to those matters which the Committee feels should be the subject for such Parliamentary debate; and
- (h) make such recommendations as the Committee sees fit and subsequently receive comments and reports on such recommendations from the Government.

# **Terms of References**

Pursuant to its mandate under *Standing Orders 69*, the Terms of Reference of the Committee in this instance is to examine the Bill and to report its observations and recommendations on the Bill to Parliament.

On behalf of the Committee, I would like to thank all those who have involved in this inquiry. I thank the Permanent Secretaries (PS) and other officials of the Government Ministries that appeared before the Committee. I also thank the Officials from the Central Bank of Solomon Islands who present a brief outlook of the country's economy and on Government's budget for 2013.

I wish to acknowledge the tireless of the Committee Secretariat and Hansard staff for supporting the inquiry. I also thank the Clerk and the staff of Parliament who have devoted their time and effort in ensuring that the Committee had resources to complete this inquiry.

Finally, I would like to thank my fellow Committee Members for their commitment and participation in this inquiry.

# **Executive Summary**

Essentially a supplementary appropriations estimate is necessary to inform Parliament on spending done on Contingency Warrants and Advance Warrants Appropriated in 2012 Appropriation Bill 2013. Furthermore, a supplementary appropriation is required for line ministries to request for further budget they need to get approval from Parliament for spending in the remaining half of the year. The 2013 Supplementary Appropriation Bill 2013 (Bill) was submitted to Parliament on 19th September 2013. Following that, the Public Accounts Committee (PAC) conducted its hearings into this Bill from 23rd to 27th September 2013 where 23 line Ministries including the Central Bank of Solomon Islands (CBSI) appeared before the Committee.

The Bill seeks to authorise the legal authorization on supplementary expenditure of \$242,954,113, of which \$18,332,535 is issued under Contingency Warrants, \$26,707,078 issued under Advance Warrant and \$143,226,771 to supplement Recurrent and \$33,400,000 to Development Expenditures.

# The Committee in its findings noted that:

- the variations in appropriation reflected in the 2013 Supplementary Appropriation Bill 2013
  indicated the government's ill decisions and shifting of focus from its government policy by
  cutting back budget appropriated to government line ministries and using it to other activities.
- the cutting back on the development budget appropriated for development projects under the line ministries has affected the programs undertaken by the line Ministries and other contractual obligations pending to be paid by the government. The Committee raises concern on the interlocutory obligations on contracts that the government is privy to pay.
- the Government has failed to drive towards its government policy, but drive towards pressures
  as it comes. The Committee noted that one of the examples of this pressure is the issue of SINU.
- With regard to this 2013 Supplementary Appropriation Bill 2013, it is evident that the consultation between the ministries and Ministry of Finance and Treasury has not been robust.

# Summary of Recommendations

# Recommendation 1:

The Committee recommends that MDPAC set up robust mechanisms in the **Monitoring and**Evaluation unit to monitor the progress of development projects in line ministries and to ensure that projects are implemented as planned.

## Recommendation 2:

Following recommendation 1 above, the Committee further recommends that the annual budget cycle starts in July so that project work plans are received by MDPA and approved well in time for project implementation by January of the new fiscal year.

#### Recommendation 3:

That the Monitoring and Evaluation Unit of MDPAC increases its capacity with each officer assigned to monitor the implementation of certain projects throughout the financial year.

#### Recommendation 4:

Budget cuts and variations in Appropriations have serious implications on government programs and services. The Committee encourages the Ministry of Finance to exercise measures that give predictability to line ministries so as to avoid budget problems into the first quarter of a given year. One reason making this is to accommodate original bids from line ministries for the following year.

#### Recommendation 5:

The Committee recommends that the Ministry of Finance engage in budget consultations with line ministries before making changes to their development budget subheads. The committee noted from the inquiry that most ministries were not consulted on their important developmental budget heads before cuts were made.

## Recommendation 6:

The Committee recommends that the government should have planning and budgeting processes that accommodate areas of its major policies to avoid over-run of the budget.

# Recommendation 7:

The increase in levels of public scholarships is unsustainable. The Committee recommends that the Ministry of Education and Human Resources Development in collaboration with SINU;

- explore opportunities for the participation of the private Sector in provision of scholarships.
- ii. explore Students loan schemes
- iii. explore Students cost sharing schemes

# Recommendation 8

The committee is concerned about the robustness and transparency of tender and procurement systems across all government ministries, especially with the Ministry of Finance and Treasury is to be vigilant

against inflated and fraudulent contracting, and therefore recommends that the Parliamentary Expenditure Committee (PEC) take on its mandated role to monitor how Public fund is expended.

# Chapter 1 Introduction

# 1.1 About the Inquiry

The Public Accounts Committee ("Committee") has concluded its review and report on the 2013 Supplementary Appropriation Bill 2013 ("Bill"), introduced in the House by the Minister of Finance and Treasury. The Bill was submitted to the Speaker through the Clerk to Parliament as required under the *Standing Orders*<sup>2</sup>. The Speaker examined the Bill,<sup>3</sup> endorsed it and the Bill was duly deemed to have been presented to Parliament according to Standing Order 46.

The Bill is received by the Speaker of Parliament on Thursday 19th September. There is limited time frame given to the Committee to conduct its hearing. The Committee was unable to hear from all 24 Ministries and departments whose Heads appear in the Bill and thus, resolved to take evidence from only 21 Ministries and requested written submission from other three (3) ministries.

According to government business for the current (4th) meeting of Parliament, the first reading of the Bill occurred on Monday, 30 September 2013 and the second reading of the Bill was done on Tuesday, 1 October 2013.

# 1.2 The establishment of the Committee

The Public Accounts Committee (Committee) is established by the Parliament under Standing Order 69 of the National Parliament of Solomon Islands.

# 1.3 Role of the Committee

As one of its functions in its Terms of Reference (TOR) in page iv above, the Committee is established to examine the 2013 Supplementary Appropriation Bill 2013 (Bill) and to report its observations and recommendations on the Bill to Parliament.

# 1.4 The Conduct of the Inquiry

# 1.4.1 Submissions

Due to very short notice and given for the Committee to inquire into the Bill, there was no call for submissions made through local media outlets. However, different Government Ministries were directly informed through correspondences and phone calls.

In total, the Committee received three (3) written submissions from the Ministry of Forests, Ministry of Communication & Aviation (MCA) and the Central Bank of Solomon Islands (CBSI). Despite constant reminders from the Committee through telephone calls and emails for submissions from the Ministry of Rural Development (MRD), the Committee received no submission from the Ministry of Rural Development. (Lists of submissions can be found in Appendix 1).

# 1.4.2 Hearings

The Committee considered the Bill and heard evidence from relevant government ministries on Monday 23<sup>rd</sup>, Tuesday 24<sup>th</sup>, Wednesday 25<sup>th</sup>, Thursday 26<sup>th</sup> and Friday 27<sup>th</sup>, September 2012. Following its review, the Committee submits this Report to Parliament, with recommendations, for the information of Members and for Parliament's consideration.

The Committee heard evidence from 59 witnesses representing 21 Ministries which had obtained funding under Contingency and Advance Warrants and further additional funding and from CBSI. (A full list of witnesses who appeared before the Committee can be found in Appendix 2).

# 1.4.3 Transcripts

# 1.5 Overview of the Report

This report has been organised into four (4) Chapters. Chapter 2 provides background information on the financial regulations governing the Supplementary Appropriation processes.

Chapter 3 looks at Issues gathered from witnesses through the hearings conducted.

Chapter 4 provides recommendations proposed by the Committee.

# Chapter 2 Background

Section 101 of the Constitution defines the process and conditions in which funds may be withdrawn from the Consolidated Fund. The issuing of funds under a Supplementary Appropriation Bill (SAB) is provided for under section 101 (2) [b] of the Constitution; and also the provisions of sections 103 or 104 are satisfied.

The process is further detailed under section 15 (Contingency Warrants) of the Public Finance and Audit Act [Cap. 120], (FI) 182 to 186 of the Financial Instructions Rules and section 102 (3) of the Constitution. Intrinsically, this is designed to be a transparent process to ensure that public resources are safeguarded in the interest of the people of Solomon Islands.

The Public Accounts Committee (Committee) is responsible for the examination of draft estimates that support Appropriation Bills as well as Supplementary Appropriation Bills. The Committee subsequently reports on its findings to Parliament for the purpose of properly informing Members of Parliament and raising matters that will assist them in their deliberations.

# Objective

Aside from the parliamentary oversight responsibility that is often exercised by the Committee, the object of this Report is to inform the Members of Parliament on significant issues pertaining to the Bill, which were examined by the Committee.

The Committee undertakes its reviews and examinations on the Bill within the parameters of the laws underpinning government finances. Furthermore, the Committee believes that its assessment must also be underpinned on sound economic strategies that are essential to achieving the common objective for which Parliament has allocated resources.

# **Chapter 3** Summary Report on Issues

The Committee commenced its Hearing into the Bill on Monday, 23<sup>rd</sup> September 2013 and concluded its Hearing on Friday, 27<sup>th</sup> September 2013.

The Bill seeks to authorise the legal authorization on supplementary expenditure of \$242,954,113, of which \$18,332,535 is issued under Contingency Warrants, \$26,707,078 issued under Advance Warrant and \$143,226,771 to supplement Recurrent and \$33,400,000 to Development Expenditures. The following is a summary of key findings and common themes discussed during the Committee Hearings. The issues raised below were also highlighted in preceding Supplementary Appropriations.

# 3.1 Contingency Warrants

The Contingency Warrant (CW) of \$18,332,535 has a recurrent amount of \$8,332,535 and \$10,000,000 expended by two Ministries. These amounts were funded but not appropriated. The funds are new and therefore needed to be appropriated by Parliament, hence the 2013 Supplementary Appropriation Bill 2013.

The Committee had repeatedly cautioned the Government in past PAC reports about the use of CW. It is disheartening to note that a state mechanism such as the Executive government through the Office of the Prime Minister can operate above the limits of the constitution.

The Committee noted that \$18,332,535 million were issued to two Ministries and is outlined below;

During the PAC Hearing a number of grave concerns especially in the budgetary system was unveiled that required explanation by especially the Ministry of Finance and Treasury (MOFT).

# 3.1.1 Contingency Warrants

Costs of two events, the Fiji Prime Minister's attendance of the 35th Solomon Islands (SI) Independence celebrations of \$2,800,084 and RAMSI's 10th Anniversary Celebrations of \$5,532,451

were provided for under the Contingency Warrants. The strict wordings of the application of the Contingency Warrants under the Constitution limit application of Contingency Warrants to cases of 'urgent and unforeseen' circumstances only.

It is a gross disregard to the provision of the Constitution to apply CW for cases of not 'urgent and unforeseen' in nature. The Celebrations of the SI Independence day is an annual event. It therefore cannot be considered as 'urgent and unforeseen'.

Similarly the 10 Anniversary of the RAMSI would be seen as an annual event that could not fall properly within the constitutional provision of an 'urgent and unforeseen' circumstance. The Office of the Prime Minister & Cabinet (OPM&C) even had a PS responsible for RAMSI Affairs and the committee wondered why costs of this celebration were not even thought of by the office. The Committee feels that it is a matter of great concern to apply the provisions of the constitution or any legal instrument strictly for the sound operations of the machinery of government.

# 3.1.2 Achievement of 36% of Development Budget

PAC learned with great concern the retardation in the implementation of planned development projects. It was revealed by the Ministry of Development Planning and Aid Coordination (MDPAC) that to date 36% of planned development projects for 2013 have been implemented.<sup>4</sup>

The Committee noted that this is the lowest rate for any given fiscal year which has just only 2 months before the end of the financial year. Many instances in the past, line ministries blamed the MDPAC for delaying processes in the implementation of their Projects. The Committee is content to hear that MDPAC and the MoFT are engaging in reforms to make the implementation processes simpler for line ministries. The propose that changes are made in the timeframe of the budget cycle to cater for timely implementation of the development budget.

However, the Committee heard that there are only 3 personnel in the Monitoring and Evaluation Unit in MDPAC and increased capacity is needed in that unit in order to effectively coordinate between line Ministries and MoFT.

# 3.1.3 Unprocedural Practices

PAC learned from the Prime Minister's Office that hiring of boats for the Prime Minister during his internal visits and tours to various places in the country was not conducted according to the approved financial regulations and procedures.<sup>5</sup> It is worrying to note such a Premium Institution in the government acting in breach of the Financial Instructions and other financial regulations setting very bad examples for others to emulate.

When the same shipping agent boat is used and proper competition for the boats' assessment and hire was lacking, there is room for doubts of employment and involvement of proper practices in the process.

# 3.1.4 Gross Mismanagement of the Budget

The Committee is concerned that funds that were lawfully appropriated for by Parliament are mismanaged or misappropriated through ill-conceived decisions made by the Executive. The PS of the Ministry of Finance and Treasury (MoFT) informed the Committee that the ministry is trying to manage cash flow as a result of,

"... pressures from commitments that are being made by the government.... we are kind of using available funds to be able to afford or release."  $^{6}$ 

The 2013 Supplementary Appropriation Bill 2013 is the biggest supplementary budget ever, brought to Parliament. The sizeable total sum of \$242,954,113 in the bill reflects the enormity of bad planning by the government.

Overall, the government in a small pace of time has lost sight of its priorities on; improved conditions and salary of teachers, Tertiary students both overseas and at the Solomon Islands National University (SINU) and Medical Services. The priority of this country and that of the ruling government has somehow disconnected in the way the budget is managed. The government defiantly squander people's money amidst the adversity they faced in the education and Health sector.

# Change of Government Policy

SINU

The Committee noted that of the total supplementary appropriation, newly established Solomon Islands National University (SINU) received 46.48% of it of \$115,783,918. This is 195.65% higher

than the total variation in 2013 approved appropriation of \$39,163,000 adversely effecting well planned and approved projects and programs of 16 Ministries.

The PAC considered such a change in policy in reducing approved appropriations that denies Ministries to carry out their planned activities, programs, projects is not a sound management practice. Apparent short remedial measure such as fixing the unplanned change in policy of the establishment of SINU weakens the sound practices of developing long term strategic plans by Ministries.

From this short term fixing exercise of cutting approved appropriation to increasing the supplementary appropriation to SINU it appears convincingly strong that the decision to establish SINU was not properly assessed to determine the costs involved initially.

While the Committee supports the governments' commitment to Education as worthy policy goals it also believes that the budget to support that commitment should be planned properly especially in the Ministry of Education where data for forward planning and budgeting purposes is readily available from previous records.

# Outstanding Tuition fees at Regional Institutions

The Financial Controller of the Ministry of Education confirmed to the Committee that the tuition fees for the second semester for SIG sponsored students in regional universities is still pending payment. As this report is tabled, Fiji National University has only 2 weeks of lectures left and it seems like students have been attending classes illegally and do not know their fate in the next few weeks.

At home, the committee is informed that the government is still budgeting to pay for arrears as far back as 2008 to SICHE. The subhead *000-04901-5600* was initially budgeted to cover government bills incurred from SICHE in the last 5 years. It has now been fully shifted to support priority areas in tertiary education and electricity bills for KG VI. The committee urges the government to make decisions properly and make provisions in the 2014 budget to clear the arrears.

# 3.2 Advance Warrant

The Committee notes that for the record this is the third time an Advance Warrant (AW) had been issued under *section 13* of the Public Finance and Audit Act.<sup>7</sup>

In evidence, the Committee noted that in keeping with Section 13 of the PFA Act, the Minister of Finance may authorise advances from recoverable monies provided that such advances are paid to the Consolidated Fund within 12 months of the end of the financial year, which in this case is 31 December 2014 and where the amount required exceeds that available under an existing appropriation. Under the 2013 Appropriation Act 2012, up to \$150 Million limit is set by Parliament. Under Section 13, the total advance is \$26,707,078 was advanced by six ministries and these have been received as outlined;

The Committee commends the government and the Ministries concern for their use of AW for Expenditures earmarked for funding by the donor partners. AW however, represents a threat to the budget and the Committee believes there should be some form of legislative control on the use of AW similar to the process for CW.

In evidence, Dr Christian Ramofafia, Permanent Secretary, Ministry of Fisheries and Marine Resources inform the Committee that the Advanced Warrant is to cover the budget for Mekem Strong Solomon Islands Fisheries Project (MSSIF).8 It is a support program for year but it was not included in the Ministry budget submission last year and the Ministry decided that it is important that it is put under the Supplementary so that it recognised as an Advanced Warrant from now under the Ministry's budget. The Budget support is funded by New Zealand Aid to support the Mekem Strong Solomon Islands Fisheries Project through the procurement system of the Ministry of Finance and the Solomon Islands Government.

# 3.3 Variations in Appropriations

The Committee also noted that this is the first time where a "variation in appropriation" comes to Parliament through the Supplementary Appropriation Bill and commends the government for taking the right part in bringing this to Parliament. The PS of the Ministry of Finance claimed these are budget savings from the development budget of other line ministries.

"... we have been able to make savings mostly in the development estimates. This is something that we have not been able to do for a long, long time. So this is new for this particular Supplementary Appropriation. This is made up again of savings in the Development Budget where we have to cut or make reductions to provisions made in the Development Budget. This is a very difficult decision, but the savings that we have been able to make are based on the trends that we have been able to witness in terms of the implementation and execution of the projects." 9

The Committee understands that, technically these are not budget savings. These monies are not utilised by lack of implementation and delivery of services by the respective ministries. Some 16 Ministries were affected by the Variations in the budget.

# 3.3.1 Approved Appropriation Cut without Consultation

Interestingly, the Committee noted that the variations in Appropriations do not affect the subheads for *overseas travel at* all. All other important development projects in those Ministries were cut. This leaves the question of where government priority is.

A number of Ministries expressed great disappointments in the cut of their approved budgeted provisions without consultation. They shared revealing examples of variation of appropriations without consultation as follows:

# Ministry of Environment, Climate Change, Disaster Management and Meteorology (MECCDMM)

PAC was told that the Central Tender Board had already tendered out the Concept Note and the designing of the plans for the construction of MECDM Office Building. They were shocked to see and learn from the 2013 Supplementary Bill that their originally approved \$2,930,000 for the construction of the MECDM Office Building had been cut without any consultation with them. The planned invitation of tenders for the construction of MECDM Office Building had to be called off. <sup>10</sup>

# Ministry of Lands

Another similar case was revealed with the Ministry of Lands. A total of \$2,000,000 was reduced from three approved projects – MLHS Extension project - \$500,000; Lands Provincial Staff Housing Program - \$1,000,000; Honiara Building Assessment and Valuation - \$500,000.

The Honiara Building Assessment and Valuation project was in its initial stages of implementation. Concept Notes and the design of the building were completed; tenders were received and awarded.

Contracts were signed. With the knowledge of the unplanned removal of the entire \$500,000 approved appropriation for the project, the Ministry is faced with an embarrassing, unethical situation of how to find funds to honor their contractual obligations.

# Ministry of Home Affairs

Another shocking revelation was the cut of \$2,000,000 from the recurrent budget of the Ministry of Home Affairs for the registration of voters for the new voters' registration system for 2014 National Election. Permanent Secretary to Ministry of Home Affairs (MHA) learned of this information only from the copy of the 2013 Supplementary Appropriation Bill 2013.<sup>11</sup> The responsible Permanent Secretary called the Permanent Secretary MoFT to raise his concern. He received acknowledgement and acceptance of responsibility for the reducing of the recurrent registration voters approved appropriation without consultation. PS MoFT assured PS Home Affairs that they will remedy the situation. Such an assurance without proper earlier consultation to reduce the approved appropriation for the 2013 registration of voters for the new system is not an acceptable practice.

The action of MoFT in reducing approved budget for 2013 without consulting the responsible line Ministry calls into question the whole budgetary process. A disregard for the very important planned activity of the preparation of the new registration list for the 2014 National Election is a serious matter. Until the 2014 Appropriation Bill is passed in Parliament and a new appropriation is approved, no voters' registration activity will be undertaken in 2013 mounting great strain on the timing to run the nation-wide program of conducting the registration of voters for all the constituencies for the new system.

# Ministry of Infrastructure Development

The Ministry of Infrastructure Development (MID) is affected in that funds for chemical testing of the Soil structure from the worksite for an Engineering complex is completely shifted from the Ministry. The building will become an infrastructure that will support long-term economic growth prospects of the country by the administration and implementation of infrastructure projects.

# Ministry of Health and Medical Services

The Ministry also raises concern over the effect and the impact in deducting funds appropriated for development projects or continues development project this will have on the Ministries.

In his evidence, Dr. Lester Rose, Permanent Secretary, Ministry of Health and Medical Services (MHMS) inform the Committee that due to the variation in appropriation policy of Government, the funds appropriated for the Ministry's development projects namely the SIMTRI Building, Refurbishment of National Medical Store (NMS) Warehouse, National Lab Development and Lambi Clinic Renovation were deducted by the Government and hence, the Ministry has decided to move these projects over to next year, considering the new medium term development budget that the government has put in place per proposed for 2014 to 2018.<sup>12</sup>

# Ministry of Forestry and Research

Under the Ministry of Forestry and Research, in its original budget, \$400,000.00 was allocated for Carbon Plot re-Measurement. However, under this variation in appropriation program, the total budget allocated for Carbon Plot re-Measurement was deducted leaving the project uncompleted. The program was started in 2012 in both Malaita and Guadalcanal Province and it was the Ministry's intention to establish the similar program in Isabel Province and other Provinces in the Solomon Islands.

In his evidence, Kedson Ago, the Director of Forestation, Ministry of Forestry and Research expressed that,

"...Anything for the foregoing of the \$400,000 it will affect the program. That means for this year it looks like there is not much work to be done. The other part of that program we also do the MRV which is the monitoring, verification and reporting of carbon sampling. For further information this plot we will include the carbon surve...We try to work out and monitor how much carbon our forest have and we need to set a base line or reference level and would equip us for to take part in this big carbon trade where much talked about it." <sup>13</sup>

## Office of the Prime Minister and Cabinet

The Office of the Prime Minister and Cabinet was allocated \$1,000,000.00 in the 2013 Appropriation Bill 2012 for land institutionalisation program. However, under this variation in appropriation \$700,000.00 was forgone by the Government to be used for other priorities. In evidence, Mr. Pellion Baure inform the Committee that this project comes from the development budget and the MDPAC is responsible for programs do not actually eventuate and they will deduct various amounts from every ministry.

# Ministry of Fisheries and Marine Resources

The Ministry of Fisheries has a total of \$8,200,000 in its original estimates under its development project plans to be used for the Fish Aggregate Device Program, Rehabilitation of Fisheries Centre, Tuna Loin Factories Suava and Tenaru and Wantok Project (Doma). During the Committee

hearing, the Committee noted that the Government has shifted the focus to its priorities, this is evident in the huge funds appears in the Ministry's variation in appropriation of \$5,959,000.00.

The Committee raises concern that such huge cut on the budget will comprehensively cut in the Ministry's performance in their progress to undertaking these development projects.

In his evidence, Dr Christian Ramofafia, Permanent Secretary, Ministry of Fisheries and Marine Resources expressed that;

"I think to be honest here, I was a bit surprised as well when they take out that amount of money from us because that was not the amount that we agreed upon for them to take out from us. The amount that I asked them to take out from us was just \$2 million and small bits from every projects that we have but when I see it last week I was not happy because they take out almost 2/3 of the project allocations." 14

# Ministry of Mines, energy and Rural Electrification

The Ministry of Mines, energy and rural electrification was appropriated the original budget of \$2,000,000.00 specifically for Renewable Energy for Provincial & Industrial Centres and the Community Micro- Hydro Feasibility Studies program. With the government undertaking under the variation in appropriation program, \$1,750,000.00 was deducted from its original estimates.

In his evidence, Mr. Barnabas Anga, Permanent Secretary, Ministry of Mines and Energy and Rural electrification inform the Committee that; with the cut to the Renewable Energy for Provincial & Industrial Centres, the Ministry could only get equipments with what they have at the moment; the Ministry has to wait for next year to do installation. Mr. Anga in his further evidence to the Committee stressed that;

The second project that has been removed from our budget is the 'Renewable Energy for Provincial Centres' and that covers a lot of programs that we have with donors. Like we had one with the Asian Development Bank (ADB) where we are looking at the feasibility studies for Hydros at Lata, Auki, Huro in Kirakira, Ringi and Choiseul Bay; with that removal of the budget it is going to affect the program of ADB with us. And the second one is also a program we had with SPREP, and that is wind monitoring so the money would have assist us to doing installation of wind stations so that would delay the program for another year again. Those are the effects the Ministry of Mines and Energy. 15

# 3.4 Additional Recurrent Supplementary Expenditures

The additional Supplementary Expenditure of comprises of a recurrent of \$143,226,771 million, a budget support of \$21,247,729 million and development budget of \$\$33,400,000 million.

# 3.4.1 Ministry of Communication & Aviation

In his submission to the Committee, the PS of the Ministry of Communication & Aviation (MCA) provided the explanatory notes on subhead 0003-4731-5250: \$27, 400, 000 which is an additional

*Development Supplementary Expenditure* in the Bill.<sup>16</sup> The money is to cater for upgrading of Munda airport so that it can comfortably accommodate international flights.

# 3.4.2 Budget Over-run on Scholarships

The bulk of the money, \$115,785,918 in the 2013 supplementary budget will go towards the Ministry of Education to meet tertiary scholarships. It has become normal for the MEHRD to submit bids for extra funds for scholarships in Supplementary Bills.

Scholarship costs are not unforseen issues in the budget process because every year there is data available to plan for the following year. The Under Secretary of the MEHRD was questioned whether the ministry has plans to avoid this case on scholarships funding recurring every year in the Supplementary Bill. His responded,

"... the actual that we requested was not granted to us. And we have already submitted a budget for next year based on the actual that we have incurred this year. We just hope that it goes through so that we don't have to come with all these supplementary request again."<sup>17</sup>

# 3.4.3 Lack of Specialist Doctors

PAC learned with great concern the drain out of local specialist doctors. Many have left to greener pastures in the regional countries. The country lacks specialist doctors to take up positions other urban centers like Kilu'ufi on Malaita and Gizo in the Western Province. With the expected increase in qualified doctors graduating and returning from Cuba in 2014, the country lacks specialist doctors to supervise the new graduate doctors.

# Chapter 4 Recommendations

The Committee acknowledge the views expressed by witnesses that appeared before the Committee. Upon completion of the hearing into the 2013 Supplementary Appropriation Bill 2013, the Committee made the following recommendations.

# Recommendation 1:

The Committee recommends that MDPAC set up robust mechanisms in the **Monitoring and Evaluation unit** to monitor the progress of development projects in line ministries and to ensure that projects are implemented as planned.

#### Recommendation 2:

Following recommendation 1 above, the Committee further recommends that the annual budget cycle starts in July so that project work plans are received by MDPA and approved well in time for project implementation by January of the new fiscal year.

#### Recommendation 3:

That the Monitoring and Evaluation Unit of MDPAC increases its capacity with each officer assigned to monitor the implementation of certain projects throughout the financial year.

# Recommendation 4:

Budget cuts and variations in Appropriations have serious implications on government programs and services. The Committee encourages the Ministry of Finance to exercise measures that give predictability to line ministries so as to avoid budget problems into the 1st quarter of a given year. One reason making this is to accommodate original bids from line ministries for the following year.

# Recommendation 5:

The Committee recommends that the Ministry of Finance engage in Budget consultations with line Ministries before making changes to their development budget subheads. The committee noted from the inquiry that most ministries were not consulted on their important developmental budget heads before cuts were made.

## Recommendation 6:

The Committee recommends that the government should have planning and budgeting processes that accommodate areas of its major policies.

## Recommendation 7:

The Committee recommends that the Ministry of Education and Human Resources Development in collaboration with SINU;

- i. explore opportunities for the participation of the private Sector in provision of scholarships.
- ii. explore Students in-loan schemes
- iii. explore Students in cost sharing schemes

The increase in levels of public scholarships is unsustainable.

# Recommendation 8

The committee is concerned about the robustness and transparency of tender and procurement systems across all government ministries, all ministries, especially with Ministry of Finance and Treasury is to be vigilant against inflated and fraudulent contracting, and therefore recommends that the Parliamentary Expenditure Committee (PEC) take on its mandated role to monitor how Public fund is expended.
