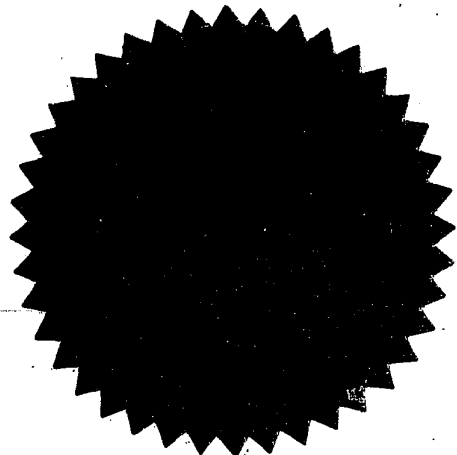

AN ACT to amend the Solomon Islands Provident Fund Act 1973.

ENACTED by the National Parliament of Solomon Islands.

*The Solomon Islands National Provident Fund
(Amendment) Act 1982*

Short
title.

1. This Act may be cited as the Solomon Islands National Provident Fund (Amendment) Act 1982.

2. The Solomon Islands National Provident Fund Act 1973 is amended -

- (a) in section 2 by deleting the definition of "domestic servant";
- (b) in section 13(1) by deleting paragraph (a) of the proviso and inserting the following new paragraph -
 - “(a) no contribution shall be payable in any one month for an employee who in the preceding month -
 - (i) earned less than \$20.00; or
 - (ii) worked for fewer than 6 days;”;
- (c) in section 38(1) by deleting the words -
“Subject to the provisions of subsection (2),” and inserting in their place the words “Subject to subsections (2) and (3),”;
- (d) in section 38 by adding the following new subsections -
 - “(3) A member may pledge up to two-thirds of the contributions credited to his account in the Fund by way of guarantee for a loan from -
 - (a) a bank licensed under section 6 of the Banking Act 1976;
 - (b) the Development Bank of Solomon Islands; or
 - (c) the Solomon Islands Housing Authority.
 - (4) An amount pledged under subsection (3) shall be realisable by the lender only where the member dies or withdraws from the Fund under section 32.”;
- (e) in the First Schedule paragraph 1 by deleting the words “years and any domestic servant”.
