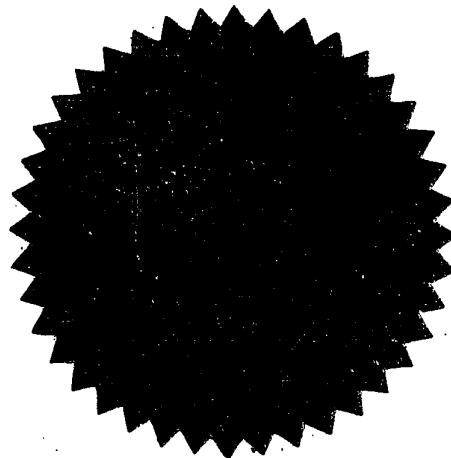

AN ACT to authorise a supplementary appropriation to the service of the year ending the 31st December 1981.

ENACTED by the National Parliament of Solomon Islands.

- Short title. 1. This Act may be cited as the 1981 Supplementary Appropriation (No 3) Act 1982.
- Authorisation of issue of \$632,000 from the Consolidated Fund. 2. The issue from the Consolidated Fund is hereby authorised of a sum not exceeding six hundred and thirty-two thousand dollars to be applied to the service of the year ending 31st December 1981.
- Appropriation. 3. The sum specified in section 2 shall be appropriated for the supply of the head specified, and in the amount specified, in the Schedule.
