AN ACT to appropriate eight million one hundred twenty four thousand one hundred and ninety five dollars to the service of the year ending the 31st December 1984.

ENACTED by the National Parliament of Solomon Islands.

Short Title.

1. This Act may be cited as the 1984 Supplementary Appropriation (No. 2) Act 1984.

Authorisation of issue from the Consolidated Fund of \$5,124,198 to the service of 1984.

2. The issue from the Consolidated Fund is hereby authorised of a sum of eight million one hundred and twenty four thousand one hundred and ninety five dollars to be applied to the services of the year ending 31st December 1984.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the Heads specified, and in the amounts respectively specified in relation thereto in the Schedule to this Act.

Development Loans.

4. Section 4 of the 1984 Supplementary Appropriation Act 1984 is hereby repealed and replaced by the following new section -

"4. The Second Schedule under section 5(1) of the 1984 Appropriation Act 1983 is hereby repealed and replaced by the following new Second Schedule".
