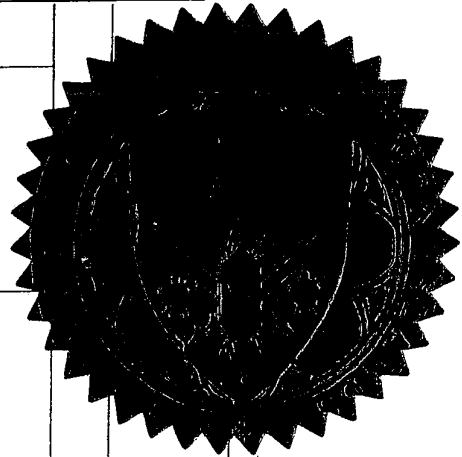

AN ACT to appropriate three million fifty six thousand and seven hundred dollars to the service of the year ending the 31st December, 1985.

ENACTED by the National Parliament of Solomon Islands

Short Title.

Authorisation of issue from the Consolidated Fund of \$3,056,700 to the service of 1985.

Appropriation.

1. This Act may be cited as the 1985 Supplementary Appropriation Act (No. 2) 1986.

2. This issue from the Consolidated Fund is hereby authorised of a sum of three million fifty six thousand and seven hundred dollars to be applied to the service of the year ending 31st December 1985.

3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation thereto, in the Schedule.
