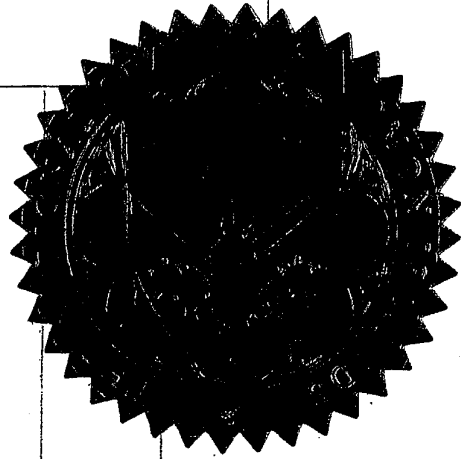



AN ACT to appropriate one million and fifty nine thousand three hundred dollars to the service of the year ending the 31st December 1986.

ENACTED by the National Parliament of Solomon Islands.

Short Title.

1. This Act may be cited as the 1986 Supplementary Appropriation (No.2) Act 1987.

Authorisation of issue from the Consolidated Fund of \$1,059,300 to the service of 1986.

2. This issue from the Consolidated Fund is hereby authorised of a sum of one million and fifty nine thousand three hundred dollars to be applied to the service of the year ending 31st December 1986.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation thereto, in the Schedule to this Act.
