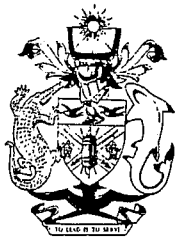

ACT ACT to amend the Customs and Excise Act.

ENACTED by the National Parliament of Solomon Islands.

Short title
and commence-
ment.

1. This Act may be cited as the Customs and Excise (Amendment) Act 1987, and shall come into operation on such date as the Minister may by notice appoint.

2. Section 15(1)(a) of the Customs and Excise Act is hereby amended by inserting therein immediately after the words "place of shipment" the words "the cost of overseas freight and insurance from the place of shipment to Solomon Islands".
