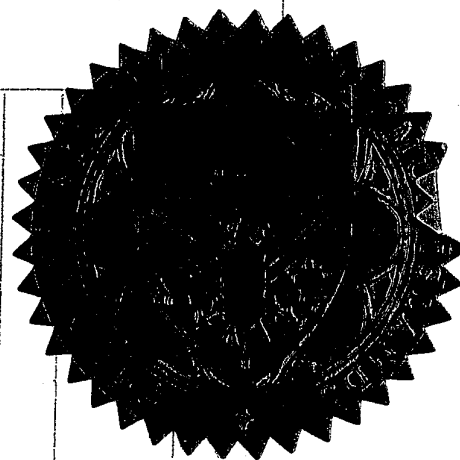

AN ACT to amend the Leadership Code (Further Provisions) Act 1979.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the Leadership Code (Further Provisions) (Amendment) Act 1987.

Amendment of section 18 of Act No.7 of 1979.

2. Section 18 of the Leadership Code (Further Provisions) Act 1979 (hereinafter referred to as the principal Act) is hereby amended as follows -

(a) by inserting in subsection (2) immediately after the words "The Commission shall investigate" the words "or may lawfully delegate or authorise any person it deems fit to investigate"; and

(b) by inserting therein immediately after subsection (4) the following new subsection -

" (5) On completion of an investigation by a person duly authorised under subsection (2), he shall submit his findings to the Commission, who shall thereupon make such determination as provided for in section 21."

Insertion of new section 23A.

3. The Principal Act is hereby amended by inserting therein immediately after section 23 the following new section -

"Practice, powers and procedure to apply *mutatis mutandis*. 23A. It is hereby declared that the powers, practice and procedure relating to an investigation before the Commission in pursuance of this Part shall, *mutatis mutandis*, be the powers, practice and procedure to investigations before a person duly authorised under subsection (2) of section 18 to investigate a complaint."
