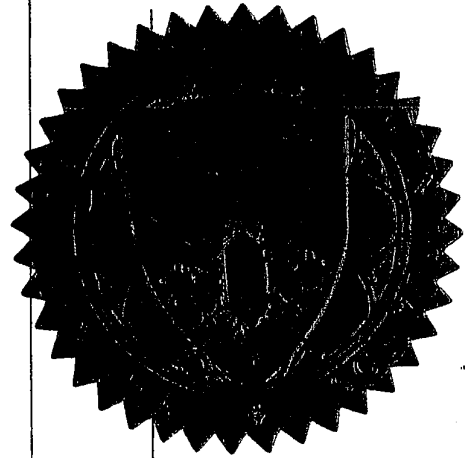



AN ACT to further amend the Gaming and Lotteries Act (Cap. 32).

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the Gaming and Lotteries (Amendment) Act 1988.

Amendment of Cap. 32.

2. The Gaming and Lotteries Act is hereby amended by inserting at the end thereof the following -
