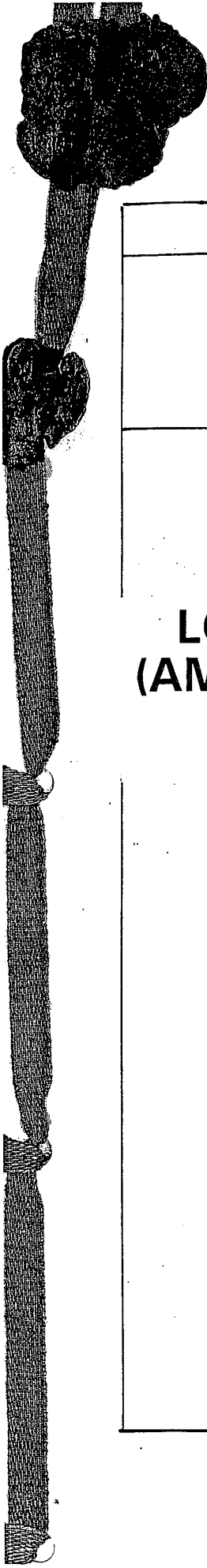



AN ACT to amend the Local Government Act.

ENACTED by the National Parliament of Solomon Islands.

Short title.

Amendment
of section 29 of
Cap. 14.

1. This Act may be cited as the Local Government (Amendment) Act 1989.
2. Section 29 of the Local Government Act is hereby amended in the following respects -
 - (a) in subsection (2) by inserting immediately after the words 'attendance allowances' the words "(which may be by way of monthly allowances or salaries)"; and
 - (b) by inserting immediately after subsection (2) the following as subsection (3) thereof -

"(3) Subject to the approval of the Minister the standing orders referred to in subsection (2), may also provide for terminal allowances or grants to be paid to a member at the end of his term of office calculated on a pro-rata basis, taking into consideration each member's period of service."
