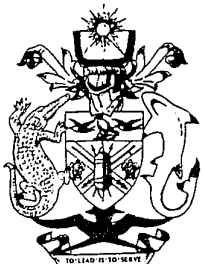
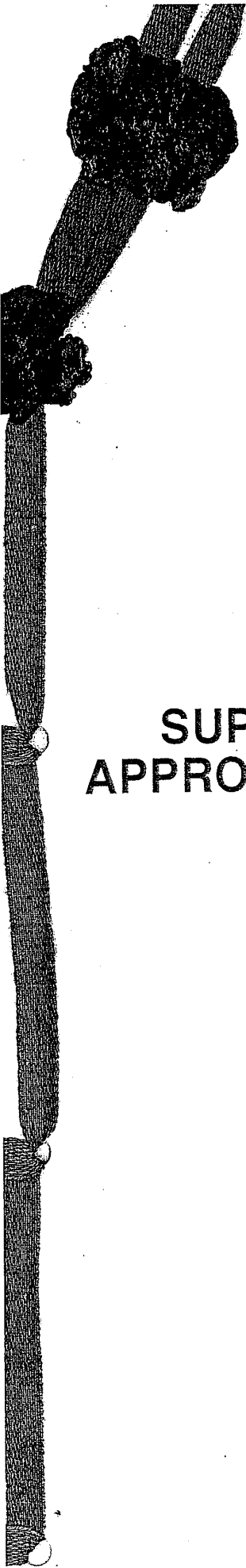

AN ACT to appropriate twenty two million eight hundred and eight thousand five hundred and twenty one dollars to the Service of the year ending 31st December 1991.

Short title. 1. This Act may be cited as the 1991 Supplementary Appropriation (No. 2) Act 1991.

Authorisation of issue from the Consolidated Fund of \$22,808,521 to the service of 1991. 2. The issue from the Consolidated Fund is hereby authorised of the sum of twenty-two million eight hundred and eight thousand five hundred and twenty one dollars to be applied to the service for the year ending December 31st 1991.

Appropriation 3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified and in the amounts respectively specified in relation thereto, in the Schedule to this Act.
