AN ACT TO Vary the Date of Commencement of the Forest Resources and Timber Utilisation (Amendment) Act 1990.

WHEREAS section 1 of the Forest Resources and Timber Utilisation (Amendment) Act 1990, inadvertently stated that the Amending Act shall be deemed to have come into operation on the 13th day of January, 1978.

AND WHEREAS it is deemed necessary to bring the Forest Resources and Timber Utilisation (Amendment) Act 1990 into operation from the date of publication in the Gazette.

AND WHEREAS it is deemed desirable that the savings provision which was numbered as section 5L(1) be renumbered as section 3 of the Amending Act.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the Forest Resources and Timber Utilisation (Variation of the Date of Commencement) (Amendment) Act, 1991.

Variation of the date of commencement of Act No. 7 of 1990.

2. Notwithstanding the provisions of section 1 of the Forest Resources and Timber Utilisation (Amendment) Act 1990 (hereinafter in this Act referred to as the "Act of 1990") the said Act shall be deemed to have come into operation on the 5th day of July, 1990, the date on which it was published in the Gazette.

Minor amendments to savings provisions of Act of 1990.

3. The provisions of the Act of 1990 specified hereunder (being savings provisions) are hereby amended in the following respects -

(a) by renumbering section 5L(1) that appears in Part IIA as section 3 of the Act of 1990; and

(b) in the section so renumbered -

- (i) by inserting in the marginal note after the words "Savings" the words "and Validation.";
- (ii) by deleting the words "For the avoidance of doubt" and substituting therefor the words "For the purposes of this Act,";
- (iii) by deleting from paragraph (a) the words "Part IIA" and substituting therefor the words "Part II"; and
- (iv) by inserting in paragraph (b) the word "corresponding" after the words "lawfully granted under the" that appear before the words "provisions of this Act,".
