AN ACT To Amend the National Parliament Electoral Provisions Act 1980.

ENACTED by the National Parliament of Solomon Islands.

Short title and commencement. 1. This Act may be cited as the National Parliament Electoral Provisions (Amendment) Act, 1992, and shall come into force on such date as the Minister may appoint by notice, published in the Gazette.

Amendment of sec.26 of Act No. 5 of 1980. 2. Subsection (1) of section 26 of the National Parliament Electoral Provisions Act 1980 (hereinafter referred to as the "principal Act"), is hereby amended by deleting the words "one hundred" and substituting therefor the words "five hundred".

Amemdment of sec.44.

3. Subsection (2) of section 44 of the principal Act is hereby amended by deleting the words "one thousand" and substituting therefore the words "seven thousand".
