

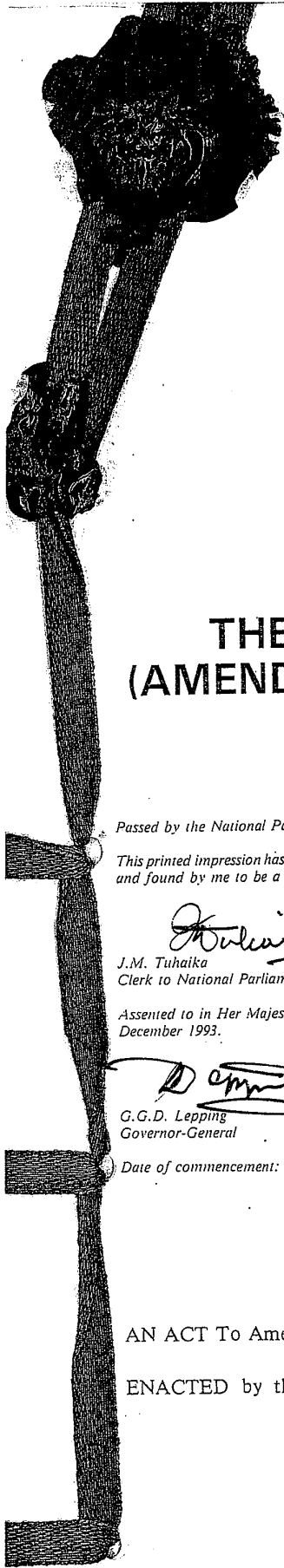

**THE INCOME TAX
(AMENDMENT) ACT 1993**

(NO. 3 OF 1993)

Short title
and commence-
ment.

1. This Act may be cited as the Income Tax (Amendment) Act, 1993, and shall come into force on such date as the Minister may appoint, by notice published in the Gazette.

Amendment
of
Eighth
Schedule.

2. The Eighth Schedule to the Income Tax Act is hereby amended in the following respects -

(a) by deleting the words "and over" that appear after the figure "\$30,001.00" in the first column and substituting therefor the words "to \$60,000.00"; and

(b) by adding at the end thereof in the appropriate columns the following -

"\$60,001 and over \$0.47."
