AN ACT To appropriate sixteen million thirty six thousand nine hundred and eighty five dollars to the service of the year ending 31st December 1994.

Enacted by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the 1994 Supplementary Appropriation Act (No. 4) 1995.

Authorisation of issue from the Consolidated Fund of \$16,036,985 to the service of 1994.

2. The issue from the Consolidated Fund is hereby authorised of the sum of sixteen million thirty six thousand nine hundred and eighty five dollars to be applied to the service of the year ending 31st December 1994.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified in and the amounts respectively specified in relation thereto, in the Schedule to this Act.
